Lake Treatment Report



We are now in our second year with "The Pond and Lake Connection (thepondconnection.com). The summer had a very clear lake and minimized algae blooms with NO BLUE GREEN ALGAE.

We did have a bit more algae than we wanted, but we will work on that again next year. We had an early start this year and now have a 3 year permit. The Pond and Lake Connection team attended a board meeting this year, performed 9 lake inspections and 8 treatments of Herbicides and/or Algaecides. A record setting amount of time on our lake vs prior lake management companies that we have worked with. We reviewed the study performed by the State of CT (paid for by your donations), and implemented suggestions. For 2018, we are investigating ways to reduce the amount of muck on the lake floor without creating turmoil to the lake. Please note that there will be no water level



Anne S. Richardson Grant

In 2016, MLIF applied and received a grant from the Anne S. Richardson Fund. Our \$10,000 award was designated for two purposes: an aquatic plant lake study and removal of trees and brush in the lake that make the lake less safe for recreation. Those projects were carried out in 2016 and the beginning of 2017. MLIF formed a committee to decide which trees to remove, bids were received and a tree company was hired to remove the dead and dying trees. The lake study was completed by Greg Bugbee, Associate Scientist, and his team from the CT Agricultural Experiment Station, Department of Environmental Sciences and his team.



At our annual "State of the Lake" meeting in March 2017, Mr. Bugbee outlined the study results. This study continues to be important to our understanding of the lake ecology and is guiding the Board and our lake management company as we work to manage the lake.
